For best results, on most absorbent surfaces, apply wet on wet, making sure to apply the amount that the material naturally absorbs evenly, avoiding the direct sunlight and the temperature of the material above 30 degrees. If applied in excess, a sticky surface film is created which can be easily removed. After 4-5 minutes from the application, remove the product in excess not absorbed, with a clean cloth or sponge; for large surfaces, use a single brush machine equipped with suitable disc. Desired protection is reached 24 hours after treatment. After application, do not step on the surface, for 12 hours.
